Minutes Woodville Water & Sewer October 06, 2020

Meeting was held via zoom and by telephone. Mike called meeting to order and Ron approved we hold the meeting via zoom and phone.

The primary purpose of the meeting was to discuss the annexing of Cedar Estates (see legal description below) to the Woodville Water & Sewer District. This is at the request of Chris Nelson for what is commonly known as the Rod Griffin property at the corner of the New Sweden Hwy and county line road.

Chris Nelson is speaking on behalf of Rod Griffin.

Mike: Cedar Estates wants to connect to our water & sewer district for purposes of administering the collection of sewer payments made to East Idaho Regional Waste Water Treatment Authority (EIRWWA)'

Tia asked for more details.

Mike: We would annex Cedar Estates to Woodville Water & Sewer District for sewer only. Mike will bill the owners of each property for a fee above and beyond the cost of each connection that is billed by EIRWWA. The estimated costs from EIRWWA to WW&S will be Hook up/permit \$4,224 and a Monthly fee \$43.63. The city of Shelley charges Hook up/permit \$4,744 and monthly of \$47.02. We could do the same.

Chris: WWS could charge an additional fee if they need to.

Ron: Just the sewer system so not much more work.

Chris: They just need someone to handle the billing. City of Shelley is willing to do the maintenance and charge WWS.

Nolan: What about fire water? If we do the connectiong will we have to provide fire protection.

Chris: No

Mike: Only question is if we can annex property that is not adjacent to existing WWS district boundaries.

Ron: If we do this do we have to connect sewer lines to existing properties in the district.

Mike: No as they are a long way from the nearest property owner.

Mike motioned to annex Cedar Estates into the Woodville Water & Sewer District. Nolan 2nd and all were in favor.

Chris: Water (from wells drilled by each lot) will only be for culinary water and not for irrigation.


Mike: This will benefit WWS because if they had to put in septic systems they would be discharging directly to our water source from the aquifer.


Mike will provide the needed will serve letter to Cedar Estates noting that Woodville Watyer & Sewer District has agreed to annex the property.






MASTER PLAN CEDAR ESTATES PHASES 1-4
