NOTICE IS HEREBY GIVEN that upon the Order of the Bonner County Board of Commissioners dated the 28th day of November, 1994 that an election will be held to determine whether or not the North of the Narrows Fire District shall be formed.

The election will take place on Tuesday, the 7th day of February, 1995. The hours of said election will be from 8:00 AM until 8:00 PM. The polling place for said election will be at the residence of Mr. Dean Fiedler which is located at Lot 1, Ridgeview Terrace in the Huckleberry Bay Subdivision at Priest Lake, Idaho.

Each person casting a ballot at said election will be required to take an elector's oath which states in part:

..."That I am a citizen of the United States of America, eighteen (18) years of age or older and am qualified to vote at general elections in the State of Idaho and that I have been a bona fide resident of said proposed District for at least thirty (30) days next preceding this election..."

The boundaries of the proposed North of the Narrows Fire District are as follows:

All that land lying between the ordinary high water mark of Priest Lake, in Bonner County, Idaho and the following described course:

Beginning at the Meander Corner at the intersection of the Shoreline of Priest Lake and the southern boundary of the NE 1/4 of Section 15, Township 61 North, Range 4W, Boise Meridian, thence east along the Southern Boundary of said 1/4 section to its Southeast Corner, thence North along the Eastern Boundary of said 1/4 Section to the Centerline of the East Shore Road, thence North and Westerly along said Centerline to the Intersection with the Southern Boundary of Section 34, Township 62 North, Range 4W, Boise Meridian, thence along the southern boundary of said section and the adjacent Section 35 to the eastern boundary of the W 1/2 of Section 35, thence North along the Eastern Boundary of the W 1/2 of Section 35, 26, and 23 to the North Boundary of Section 23, thence Westerly along said Boundary to the East boundary of Section 15, then North along said boundary to of the Centerline of the East Shore Road, thence North and Easterly along said Centerline until the intersection with the North Boundary of Section 10 thence Westerly along said Boundary to the Western Boundary of said Section, thence Southerly along said Boundary to the Meander Corner at the Intersection of the Shoreline of the Thoroughfare.

IT IS ORDERED that the Clerk of the District Court for Bonner County, Idaho shall duly certify this ORDER and shall file a copy for record in the office of the County Recorder in Bonner County, and

FIRE COMMISSION DISTRICTS

Pursuant to the provisions found in Idaho Code §31-1409, we the undersigned Board of Commissioners for Bonner County, Idaho, do hereby designate the following areas to be formed into the required three fire commissioner districts, to wit;

DISTRICT ONE: Shall contain that area from the southern most boundary of the entire district north to the centerline of the Two Mouth Creek Rd.

DISTRICT TWO: Shall contain that area north of the centerline of the Two Mouth Creek Rd to the centerline of the Canoe Point Rd.

DISTRICT THREE: Shall contain that area north of the centerline of the Canoe Point Rd. to the northern most boundary of the entire district which ends approximately in the area of Sandpiper Shores.

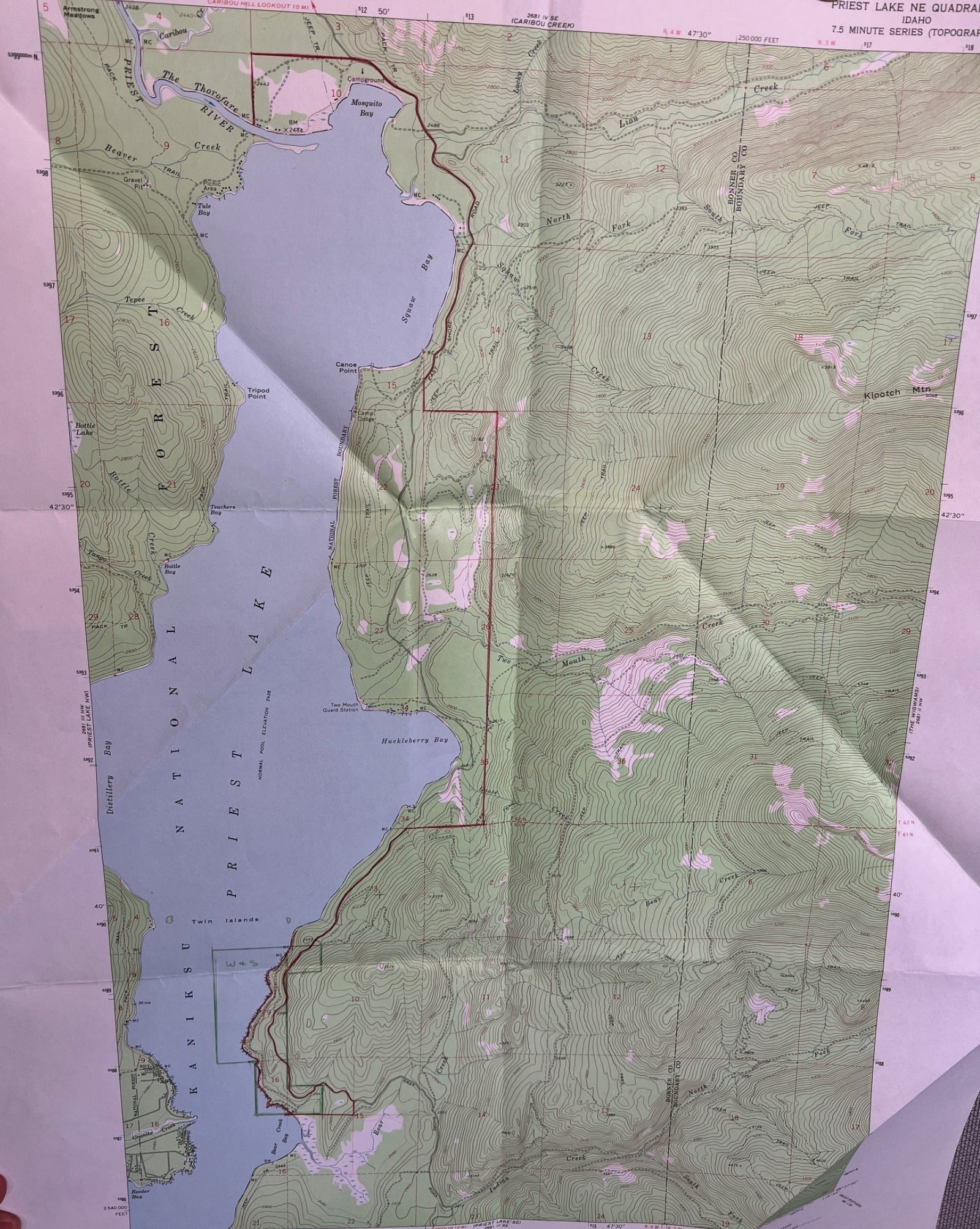
